These minutes represent the general subject matter discussed in this meeting but do not reflect a verbatim documentation of the subjects and conversation that took place.

1. Chairman Cassie Fleming called the Regular Town Board Meeting to order at 6 P.M. Present were Supervisor Steven Probst, Tess Eisenhauer, Supervisor Nicole Vee, and Clerk/Treasurer Helen G Hyde. Clerk testified the meeting was properly posted. Rusty Williams was absent
2. A motion by Steven Probst, seconded by Tess Eisenhauer to approve the Agenda, Motion carried.
3. A motion by Tess Eisenhauer, seconded by Nicole Vee to approve the Minutes of the Regular Town Board meeting March 12, 2015 . Motion carried.
4. A motion by Steven probst, seconded by Tess Eisenhauer to approve the Financial Report. Motion Carried.
5. John Darwin introduced people who were from the fire Department that attended the meeting.
6. A motion by Cassie Fleming, seconded by Tess Eisenhauer to Table the request from Pete Witt until further information can be obtained. Motion carried.
7. A motion by Steven Probst, seconded by Tess Eienhauer to approve the request from Steven Jurkovich for a permit to grade and fill 5000 square foot driveway and turn a round at Fire Lake Road. The Planning Commission also approved this. Motion carried.
8. A motion by Cassie, Fleming, seconded by Tess Eisenhauer to table the request from Joseph and Sarah Zuelke fpr a special use permit for a Hobby farm. Mr Zuelke wrote a letter to the Town Board explaining all the questions that were asked of him. The Planning Commission made three requests 1. All animals kept east of the main house 2. Wet land regulations followed. 3. Property fenced. Tess Eisenhauer abstained from voting until all clean up from County Zoning is in compliance. Then the Iron River Town Board will revisit this request. Motion carried.

9. A motion by Steven Probst, seconded by Tess Eisenhauer to grant Mr. Lind a driveway permit on Long Lake Road, to be held for a ten (10) year term. Motion carried.
10. A motion by Steven Probst, seconded by Tess Eisenhauer to Table the issue on Sanitary Lines at the Ball Field until the Town can contact the Sanitary District and obtain more information. Motion carried.
11. A motion by Cassie Fleming, seconded by Steven Probst to approve Thomas Trudeau as the lowest bidder to build the new ball field building. Not to exceed 152,080.00 Motion carried.
12. A motion by Tess Eisenhauer, seconded by Steven Probst to purchase a John Deere mower for 2899.00 and a trailer not the exceed 1500.00. Motion carried.
13. A motion by Tess Eisenhauer , seconded by Cassie Fleming to approve the purchase of the Self Containing Breathing Apparatus, the loan will be 90,480.00, for 15 years, the bids for the loan will be opened at the May meeting. Motion carried.
14. A motion by Steven Probst, seconded by Tess Eisenhauer to approve the Highway Order to vacate the three alleyways and Release of Lis Pendens to the alleys the Town has been working on for the past year. Motion carried.
15. The bids will be opened for the dump station and the sidewalks at the May Meeting

17. A motion by Tess Eisenhauer, seconded by Steven probst to adjourn at 7:02 P.M. Motion carried.
