These minutes represent the general subject matter discussed in this meeting but do not reflect a verbatim documentation of the subjects and conversation that took place.

1. Chairman Steven Probst (First Meeting) called the Regular Town Board Meeting to order at 6 P.M. Present were Supervisors Rusty Williams, Tess Eisenhauer, Nicole Vee, Johnathan Jensen and Clerk/Treasurer Helen G Hyde. Clerk testified the meeting was properly posted.
2. A motion by Johnathan Jensen, seconded by Tess Eisenhauer to approve the Agenda, Motion carried.
3. A motion by Tess Eisenhauer, seconded by Nicole Vee to approve the Minutes of the Regular Town Board meeting April 9, 2015 . Motion carried.
4. A motion by Rusty Williams, seconded by Tess Eisenhauer to approve the Financial Report. Motion Carried.
5. Citizens Comments. Therene Gazdik presented the Board with concerns about her property in Iron River which she is trying to sell. This issue will be on the May Agenda. John Darwin asked to table item number 14 until a future date. Eric Martin spoke on the Barnes Fire which was a year ago today. The thanked all the Fire Fighters for doing a great job.
6. A motion by Rusty Williams, seconded by Johnathan Jensen to move forward and abandon Rooster Road. Motion carried.
7. A motion by Johnathan Jensen, seconded by Rusty Williams to allow the Lions club to proceed with the plans to create a playground / park on the land west of the Community Center on Town of Iron River land. The Town will be liable for the insurance on this property. Motion carried.
8. A motion by Tess Eisenhauer, seconded by Nicole Vee to recommend approval for the Town of Iron River to rezone Town properties to Municipal. Motion carried.

9. A motion by Rusty Williams, seconded by Tess Eisenhauer to recommend approval for Nathan Merritt to rip rap about 30 feet of shore hillside to prevent erosion. This motion comes with stipulations which are outlined on the permit. Motion carried.
10. A motion by Tess Eisenhauer, seconded by Rusty Williams to approve the agreement with Todd Gibbon for the Dam inspection. Motion carried.
11. A motion by Rusty Williams, seconded by Tess Eisenhauer to accept Abe Ray of Rays Masonry and Concrete to install the first portion of sidewalks for the amount of \$30,490.00, with the Town paying up to \$15,245.00 of the total bid. Motion carried.
12. A motion by Tess Eisenhauer, seconded by Nicole Vee to accept the bid of \$14,830.00 from Tony Polkoski to install an underground sanitary station at Moon Lake Park. Motion carried.
13. Motions by Tess Eisenhauer, seconded by Nicole Vee to replace bad/ broken furnaces now, and then proceed to replace rest of furnaces in future. Motion carried.
14. Tabled until further notice.
15. Community Center= bids are out and to be opened on May 11, 2015: Ball Fields construction has started: Dump Station, bids opened and construction to be stated in near future.
16. Head of Department present : Mitch Steeb-Police, John Darwin- Fire, Courtney Dietsche- Library, Mike Middleman-Highway, Tess Eisenhauer- Youth Center, Gary Victorson
17. A motion by Tess Eisenhauer, seconded by Johnathan Jensen to adjourn at 7:10 P.M. Motion carried.
