1. Chairman Steven Probst called the Regular Town Board Meeting to order at 6 P.M. Present were Supervisors Rusty Williams, Tess Eisenhauer, Nicole Vee, Johnathan Jensen and Clerk/Treasurer Helen G Hyde. Clerk testified the meeting was properly posted.
2. A motion by Nicole Vee, seconded by Rusty Williams to approve the Agenda. Motion carried.
3. A motion by Tess Eisenhauer, seconded by Johnathan Jensen to approve the Minutes of the Regular Town Board meeting May 14, 2015 . Motion carried.
4. A motion by Rusty Williams, seconded by Tess Eisenhauer to approve the Financial Report. Motion Carried.
5. John Joseph and Therene Gazdik spoke about item number 6 and the conflict about selling the house that belongs to Therene Gazdik
6. A motion by Rusty Williams seconded by Nicole Vee to move forward and authorize an easement that follows the map provided to be completed by the Town Lawyer so Therene Gazdik can sell her house located on North Point Drive. Also to process with road abandonment for North Point Drive in the near future. Motion carried.
7. A motion by Nicole Vee, seconded by Johnathan Jensen to recommend approval to William Glew for a variance for a lessor setback than required. The planning commission also approved this request. Motion carried.
8. A motion by Nicole Vee, seconded by Tess Eisenhauer to approve the 2015-2016 Liquor Licenses for the Town of Iron River. Motion carried.
9. A motion by Johnathan Jensen, seconded by Rusty Williams to accept the bid to over lay the roof at the Community Center by Nasir Roofing for 20,900.00, the color with be brown. Tess Esinhauer and Nicole Vee oppose. Motion carried.
10. A motion by Rusty Williams, seconded by Tess Eisenhauer to approve the request from the Lions Club for Temporary Class B license for the Blueberry Festival on July 25 & 26 of

July at Moon Lake Park. Also approving the request for a special event permit for the parade on the 26th, the events also include noise abatement. Motion carried.

11. A motion by Johnathan Jensen, seconded by Nicole Vee to proceed with the blight ordinance for two properties, Kirk & Jill Clemmer and Bonnie Arnce. Scot Eisenhauer presents a short video of the properties. Motion carried.
12. Chairman Steven Probst approved the appointment of John Podlesny, Connie Bruegmenn, and Gary Gurski to the Police and Fire Commission.
13. The Community Center roof/ Ball Fields/ Dump Station are all in the process and moving along.
14. A motion by Rusty Williams, Seconded by Johnathan Jensen to accept the 2014 Audit and place on file. Motion carried.
