**These minutes represent the general subject matter discussed in this meeting but do not reflect a verbatim documentation of the subjects and conversation that took place.**

1. Chairman Steven Probst called the Regular Town Board Meeting to order at 6 P.M. Present were Supervisors Rusty Williams, John Rautio, Nicole Vee, Michelle Davis and Clerk/Treasurer Helen G Hyde. Clerk testified the meeting was properly posted.
2. A motion by John Rautio, seconded by Michelle Davis to approve the Agenda. Motion carried.
3. A motion by Rusty Williams, seconded by Nicole Vee to approve the Minutes of the Regular Town Board meeting August 13, 2015. Motion carried.
4. A motion by Nicole Vee, seconded by Michelle Davis to approve the Financial Report. Motion Carried.
5. No citizens comments
6. A motion by Michelle Davis, seconded by Rusty Williams to accept the bid from Northwoods Paving to black top a portion of Teepee Trail for \$ 46,937.01. Motion carried.
7. A motion by John Rautio, seconded by Nicole Vee to accept the bid from Security State Bank for \$88,380.00, 3.24%, 5 years fixed, amortized over 15 years for the Fire Department breathing apparatuses. Replacing the Community Center Roof will be \$20,900.00, 3.24 Fixed and amortized for 5 years. Motion carried.
8. A motion by Rusty Williams, seconded by John Rautio to recommend approval for Gerald and Nancy Mahowald to place a 20 X20 log cabin with a 2 x 20 porch on their property. The Planning Commission also approved this request. Motion carried.
9. A motion by Rusty Williams, seconded by John Rautio to move forward with the request from Bert Peterson to vacate a platted/unmaintained alley. Motion carried.
10. A motion by Rusty Williams, seconded by John Rautio to discontinue the service of snowplowing for the town's residents. The snowplowing service will be available to private contractors. Motion carried.

11. A motion by Rusty Williams, seconded by John Rautio to move forward with the blight ordinance for the Sterling residence. Motion carried.
12. A motion by Rusty Williams, seconded by Nicole Vee to table the request by Michelle Davis for Ashland cares until further information can be provided. Motion carried.
13. Update on Community Center Roof, the project was completed the week of September 24<sup>th</sup>. Update on Sports Building, the roof is complete and the project is moving forward.

15. A motion by John Rautio, seconded by Michelle Davis to go into Closed Session regarding the police Department salary. Motion carried. Discussion in closed session. A motion by Rusty Williams, seconded by John Rautio to reconvene from closed session. Motion carried.
16. A motion by Nicole Vee, seconded by Michelle Davis to adjourn at 6:58 P.M. Motion carried.
