These minutes represent the general subject matter discussed in this meeting but do not reflect a verbatim documentation of the subjects and conversation that took place.

1. Chairman Steven Probst called the Regular Town Board Meeting to order at 6 P.M. Present were Supervisor John Rautio, Lori Anderson. Rusty Williams, Michelle Davis and Clerk/Treasurer Helen G Hyde. Clerk testified the meeting was properly posted.
2. A motion by Lori Anderson, seconded by Michelle Davis to approve the Agenda, Motion carried.
3. A motion by Michelle Davis , seconded Lori Anderson to approve the Minutes of the Regular Town Board meeting August 11, 2016, Special Town Board Meeting July 16, 2016, and the Special Town Board Meeting August 31, 2016. Motion carried.
4. A motion by John Rautio, seconded by Rusty Williams to approve the Financial Report. Motion Carried.

9. A motion by Lori Anderson, seconded by Michelle Davis to sell the Zambonie on Wisconsin Surplus. Motion carried.

11. A motion by John Rautio, seconded by Lori Anderson to proceed onto closed session – sec 19.85 (1). A motion by John Rautio, seconded by Lori Anderson to go into open session-sec. 19.85 (2). The Board approved a \$1.00 an hour raise for the Lead Highway person from September 1, 2016 going forward.
