11. A motion by Lori Anderson, seconded by Michelle Davis to approve the line item on the 2017 Budget for the Library as an expense/revenue for the \$200,000.00 loan/donation for the library. Motion carried
12. Update: The board is still working with the Zoning department on the Comprehensive plan amendment.

14. A motion by Lori Anderson, seconded by Michelle Davis to go into Closed Session Sec. 19.85 (1). Discussion on fulltime police officer position. A motion by Lori Anderson, seconded by Michelle Davis to go into Open Session Sec. 19.85 (2)
A motion by Lori Anderson, seconded by Rusty Williams to hire Ryan Schneeburger Sec. (60.37) as a full time Police officer starting January 1, 2018 with the wage of \$21.00 an hour, to be revisited after 6 months. Vacation starts in June 2018. Sick time starts upon hire of full time. Motion carried.
